We held a General Service Board meeting on January 14, 2015. What follows are brief minutes of the meeting.

**Topics:**

- We reviewed and approved minutes from our December 10th meeting
- We are very grateful to retiring EDA email correspondent Julie E. for her years of tireless and excellent service. Julie set a high standard for all future corresponded and helped thousands of EDA members and others in the community during her tenure. We are humbled and inspired by her example.
- We reviewed the \*New\* OSFED Brochure (replaces EDNOS Brochure). Kudos to Sherian: awesome job! There may still be some revisions, however, the attached is now the working version.  
**Action Item:** Annette to send out the updated brochure with tonight's meeting minutes, and add the OSFED Brochure to the website, replacing the EDNOS Brochure
- We discussed a proposed Group Conscience Meeting Format. The content was excellent (thank you, Hannah!), but Hannah wasn't quite satisfied and has a few updates planned.  
**Action Item:** Hannah to update the Group Conscience Meeting Format. (Annette will distribute the updated version prior to the February meeting.)  
We will discuss the Group Conscience Meeting Format again in February.
- We discussed website enhancements. At our last meeting, we talked about using some of our funds to address some of the current website's issues.
  - Specifically, we want the website to be fast to load, support mobile devices, and utilize something other than html coding to render the list of meetings.
  - At present, maintaining meeting information requires someone with html skills, and that really should not be necessary. It is really important that we get the website information updated in a timely way and this is unnecessarily difficult with just one html-skilled person doing the updates.
  - A test site is available at [www.4EDA.org/test/new](http://www.4EDA.org/test/new). The site isn't ready for "prime time" yet but it addresses several issues, predominantly:
    - Faster to load – removed most of the graphically intense images
    - Simplified design – easier for someone to rebuild when we are ready for that
    - Utilizes the approved EDA logo design
  - Several expressed concern that the approved logo design is too feminine
    - We agreed to continue to use the new logo for the time being
    - **Action Items:**
      - Hannah, a graphic designer, will work on a more gender neutral image that the group can discuss at a future GSB meeting.
      - Annette will update the "cleaner" version of the website using neutral images from the current website.

- Annette will attempt to load the meeting information into GoogleDocs and try to get it to display on the meetings page.
- We discussed Big Book sections review and planning
  - The Doctor's Opinion – Sherian reached out to a member of the IAEDP board, however, that person is not currently available. Sherian contacted another resource and we are waiting for a response.
  - We agreed to tackle the remaining sections (Bill's Story, There is a Solution, More About Eating Disorders, We Agnostics, How it Works, Into Action, Working with Others, To Significant Others, The Family Afterward, To Employers, and A Vision For You) one per month, starting in February.
- We adjourned the meeting at 8:14 PM MST.
